

Activation Successes and Opportunities

Positives (+)

- Minimal mail flow and transportation issues in S&DC activations – sufficient communication/planning with processing/logistics groups resulted in positive mail prep for S&DC activations
- Successful installation and use of new equipment in S&DCs – all equipment shipped/arrived and was efficiently prepped for activations

<u>Deltas (-)</u>

- Inconsistent communication with plant modernization team in conjunction with transfer hub activations – Processing facilities not completely aware of needs of transfer hub with regards to separations and mail flow
- Confusion on ownership (Logistics/S&DC Team) of MTEL placard creation
 - Last minute training (Thursday)
 - Technical issues
 - SWI with ownership needed



Activation Successes and Opportunities

Positives (+)

 Great communication and support from Field Operations Support teams – buy in on all processes and plays resulting in site management being prepared for pending updates/changes

Deltas (-)

- Timelines for processing/logistics modeling and preparation not met for transfer hubs – sort plans/transportation plates being changed up until the day prior to activation
- Multiple S&DC activations in single district resulting in split/smaller teams – impacted timelines for completion of tasks resulting in last minute pushes for task finalization

Activation Successes and Opportunities - LTO

Positives (+)


- Great launch in Portland, minimal missed pickups requiring recovery
- Teamwork/Collaboration between stakeholders to resolve issues
- Daily improvement in both sites
- Onsite support by all departments in both sites

Deltas (-)

- Several missed pickups day 1 in Atlanta, causing recovery throughout the night
- Late trips in both sites
- Missing trips between parent/child offices



Destination Processing to Delivery Performance – All S&DCs




